DOMESTIC VIOLENCE CASES	
District Attorney's Office Identifies Domestic Violence Cases When Filing	Felonies Dept. 1/Misdo Dept. 11 - <u>After arraignment</u> , felony cases are assigned to Departments 4, 5 or 6 and Misdo cases are assigned to Department 8.
DRUG CASES	
District Attorney's Office Identifies Drug Cases When Filing	 Department 11- After Arraignment, Drug cases that are presumptively eligible for treatment (DEJ, Prop 36, & DTC) where a guilty plea has been entered are assigned to Department 10 at 8:45 on Thursdays. Misdemeanor drug cases ineligible for treatment or without an appropriate plea entered/unresolved are assigned to Department 10 at 9:00 am Mondays for PTC Felony drug cases that are presumptively ineligible for treatment are assigned to the appropriate felony alpha court. (e.g., Prior strike, H&S 11351, 11351.5, 11352 (sales), 11358, 11359, 11370.1, 11378, 11379 (sales), 11379.5 (sales), 11379.6)
CO-DEFENDANT CASES	

All felony and misdemeanor cases in which there is more than one defendant shall be assigned to the alpha department based on the "A" defendant's name, unless the defendant has a new case and dispositions have been reached for all other co-defendants.

When the arraignment court appoints the public defender to represent more than one defendant in a co-defendant case, the case as to all appearing co-defendants shall be assigned to the alpha court and set for further arraignment and identification of counsel at the next available grist calendar.

PRISUN CASES	
District Attorney's Office Identifies Prison Cases When Filing	All prison cases involving inmates are assigned to Department 1 from arraignment
	through disposition. Non-inmate prison cases are arraigned in Dept. 1 and then assigned
	to Dept. 1 in the AM through disposition.
